# African growth & new opportunities



In Africa, the modernisation of logistics has been under way for the past 15 years, with investments multiplied by three in Sub-Saharan Africa between 2001 and 2018. Significant efforts have been made in the port sector, allowing the development of **world-class hubs** such as Tangier Med.

Despite this progress, the sector remains insufficiently **competitive** and sophisticated to support African growth and the creation of the African Continental Free Trade Area and thus lacks to meet the needs of investors and entrepreneurs.

The continent's strong **dynamism**, as well as the infrastructural and regulatory specificities in each of its countries, calls operating companies to closely consider their logistics issues in Africa, with the aim of optimising their operations and development.

This is an undisputed key gathering for experts of several companies, all of them being very active on the continent and in various industries as they create bespoke **networking opportunities** between the public sector and their adjudicators to find tangible solutions to the African logistics networks, supply chain and infrastructure.
